

Charter of Live Well USA

Empowering Health, Securing Futures

Article I: Name and Motto

The official name of this association is **Live Well USA**, herein referred to as "the Association." Our motto, "**Empowering Health, Securing Futures**," encapsulates our dedication to fostering wellness and longevity among our members.

Article II: Purpose

The purpose of Live Well USA is to create a vibrant, supportive community of individuals committed to proactive health and wellness. We strive to:

1. **Promote Health and Wellness:** Encourage lifelong habits that lead to healthier, happier lives through educational resources, wellness programs, and community-driven initiatives.
2. **Empower Members:** Equip our members with tools, knowledge, and opportunities to actively improve their physical, mental, and emotional well-being.
3. **Build Community:** Foster connections among like-minded individuals who are dedicated to achieving personal growth and supporting the wellness journeys of others.

Article III: Mission

Our mission is to ensure every member thrives in their wellness journey. Through education, resources, and community support, we champion the values of proactive well-being, personal empowerment, and shared success.

Article IV: Membership Eligibility

Membership in Live Well USA is both a privilege and a commitment. The Association maintains a selective membership process to ensure alignment with our founding principles and shared values.

Eligibility Criteria:

1. **Commitment to Wellness:** Members must demonstrate a proactive dedication to their personal health and wellness journey.
2. **Employment Requirement:** Members must be currently employed in a full-time capacity in a profession that supports a balanced approach to health and wellness.
3. **Exclusions:** Membership is restricted from individuals engaged in high-risk occupations or activities that significantly impact personal wellness or safety. These may include, but are not limited to, physically hazardous or high-stress roles where long-term health may be compromised. Anyone that is currently on hospice care, in the hospital, or in an assisted living or nursing is not eligible for membership.

Membership Fees:

Members shall remit a monthly membership fee as determined by the Association's Board of Directors. Fees are used to support the programs, resources, and initiatives of Live Well USA.

Selection Process:

Applicants must complete a formal application process and may be required to participate in an interview or provide documentation demonstrating their alignment with the Association's principles. The Board of Directors reserves the right to review and approve all applications to ensure compliance with eligibility criteria.

Article V: Member Responsibilities

As members of Live Well USA, individuals are expected to:

1. Actively engage in health and wellness activities promoted by the Association.
2. Contribute to the supportive and inclusive community ethos of the organization.
3. Maintain the standards of eligibility and uphold the values of the Association.

Article VI: Organizational Structure

The governance and management of Live Well USA shall be vested in the following bodies:

1. **Board of Directors:** Responsible for overseeing the Association's strategic direction, approving memberships, and managing financial resources.
2. **Executive Committee:** Comprised of elected members responsible for day-to-day operations and implementation of initiatives.
3. **Advisory Council:** A group of wellness professionals and community leaders who provide guidance on program development and member engagement.

Article VII: Amendments

This Charter may be amended by a majority vote of the Board of Directors, provided that the proposed changes are communicated to the membership in advance and align with the Association's core values and mission.

Article VIII: Dissolution

In the event of dissolution, all remaining assets of Live Well USA shall be allocated to nonprofit organizations with similar missions, as determined by the Board of Directors.
